Program Overview: *Discussion topics*-What constitutes a safe and sound vehicle and harness for driving; how to inspect vehicle and harness for safety and suitability; preparing your horse to drive. *Demonstration and hands-on practice*--line driving; hitching and driving either a single or pair turnout under the supervision of experienced whips.

All horses and vehicles provided by Dairyland Driving Club, Inc. Participants should bring a pair of comfortable leather gloves for driving, a safety helmet, and wear suitable clothing for safely entering and dismounting vehicles. A limited number of safety helmets are available.

Cost: Full clinic participation (morning discussions, demos, line driving, driving lesson) --\$50.00 per person (\$45.00 for members of Dairyland Driving Club, Inc.). Auditor--\$25.00 (all sessions except line driving and driving lesson). *Limited number of full sponsorships available for children ages 8-18. Contact Donna Thomas for information.* Lunch provided for all participants and auditors.
