1. Monthly meetings June – Sept will be held at Noon at Fun Shows unless otherwise announced. All other meetings Oct to May are held 1<sup>st</sup> Monday of every month at 7 pm.
2. Member Fees: \$10.00 all day for single and \$20.00 per family
3. Tiny Tot Leadline fee is \$1.00
4. Age Brackets for Year-End Awards are:
  - a. Tiny Tot – 10 & Under
  - b. Children's – 13 & Under
  - c. Intermediate – 14 – 18
  - d. Sr. 19 – 39 yrs.
  - e. Sr. Sr. – 40 yrs. & Over
5. Club members are asked to use same exhibitor number for the entire season.
6. Original current negative coggins required, must leave a copy at entry booth.

## Non-Members

The following restrictions and fees shall apply:

1. Juveniles must have a parent or guardian's signature in order to ride.
2. Non-members fee for the day: \$20.00 for singles and \$ 35.00 for families.
3. Non-member fees for Tiny Tot Lead line \$1.00
4. Non-members are not eligible for year-end awards.
5. Non-members do not have voting privileges, nor will they receive the newsletter
6. Previous fees do not apply to membership.
7. Original current negative coggins required, must leave a copy at entry booth

Anyone paying their CCPR membership the day of the show must pay BEFORE they enter any classes. Otherwise they will be classified as a NON-MEMBER and any points earned that day will not count towards year-end awards.
